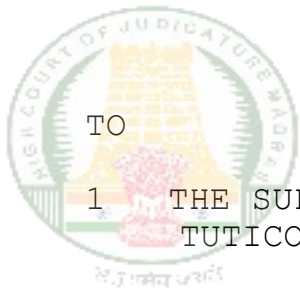
"This petition has been filed to recall the order passed in Crl.O.P.(MD)No.18044 of 2016, dated 22.09.2016.
