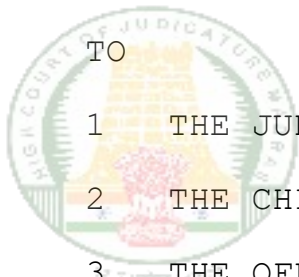
Heard the learned counsel for the petitioner and the learned Government Advocate (Crl.side) appearing for the respondent Police.
