The petitioner has filed this petition to modify the condition imposed on the petitioner vide order dated 24.01.2017 by this Court in Crl.M.P.No.514 of 2017 in Crl.O.P.No.20593 of 2016.

2.When the matter came up for hearing on 19.04.2017, this Court directed the petitioner to pay a sum of Rs.1000/- in the account opened in the name of the Registrar (Administration), (for removal of Prosopis Juli Flora (Karuvelam Trees), Savings Bank Account No.6514082295, Indian Bank, Madurai Bench of Madras High Court, Madurai on or before 20.04.2017. He further submitted that the petitioner had complied with the said direction and cost memo has also been filed to that effect.



3. In view of the same, the condition imposed on the petitioner is relaxed. However, the petitioner shall appear before the respondent police as and when required for interrogation.
