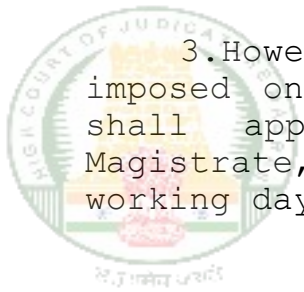
PRAYER IN CRL.M.P(MD)NO.5403 OF 2016
