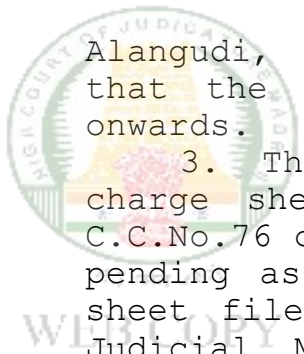

The learned Government Advocate (Crl.side) states that charge sheet filed in Crime No.113 of 2016 and is pending as C.C.No.76 of 2016 and charge sheet filed in Crime No.134 of 2016 and pending as C.C.No.12 of 2017 and in Crime No.135 of 2016, charge sheet filed and pending as C.C.No.13 of 2017 before the learned Judicial Magistrate, Alangudi, Pudukottai District. He further states that the investigation is still pending in Crime No.136 of 2016 on the file of Vadakadu Police Station, Pudukottai District and in Crime No.204 of 2016 on the file of K.K.Nagar Police Station, Trichy District.

4. Considering the above facts and circumstances of the case and also the proper compliance of the conditions by the petitioner herein, this Court is inclined to relax the condition. Accordingly, the condition already imposed on the petitioner is relaxed and the petitioner shall appear before the concerned Court, on receipt of summons.
