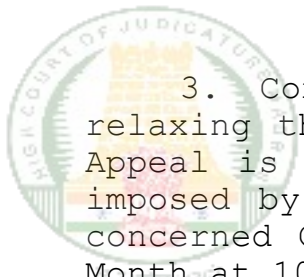
PRAYER IN CRL A (MD) NO.12/2017 :
