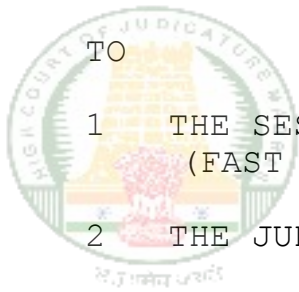
The learned counsel for the petitioners is present.
