Heard the learned counsel for the petitioner and the learned Government Advocate (Crl.side) appearing for the respondent police.

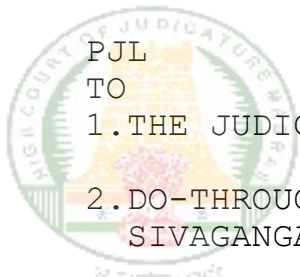
2.The learned Government Advocate (Crl. side) submitted that the petitioner is complying with the conditions imposed by this Court regularly.
