2.Accoriding to the learned Government Advocate(Criminal Side), the petitioner is complying with the condition imposed by this Court regularly.

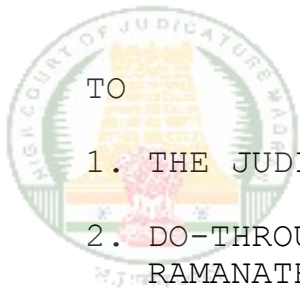
