2. According to the learned Government Advocate (Criminal Side), the petitioners are complying with the conditions imposed by this Court regularly.

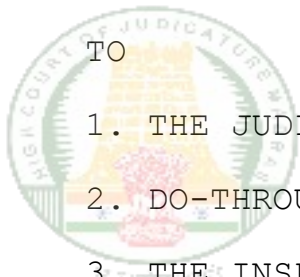
3. Considering the facts and circumstances of the case, the condition imposed on the petitioners stands fully relaxed.
