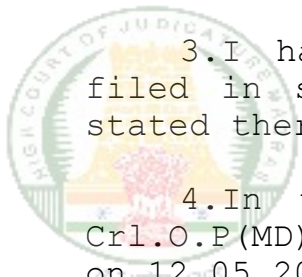
Prayer in CRL OP(MD) . 5704/ 2017 :
