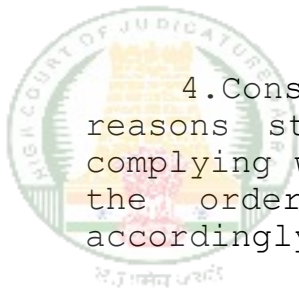

2.This Court by order dated 07.06.2017 in Crl.O.P.(MD)No.6784 of 2017 while granting anticipatory bail directed the petitioner to appear before the concerned Judicial Magistrate, within a period of 15 days from the date on which the order copy is made ready, failing which, anticipatory bail petition stands dismissed. However, the petitioner failed to do so and filed the present petition for extension of time.

3.It is seen that copy of the order was made ready on 13.06.2017 and the present petition is filed on 27.06.2017 before this Court. Hence, this petition is in time.



4.Considering the facts and circumstances of the case and the reasons stated in the affidavit, one week time is granted for complying with the conditions already imposed from the date on which the order copy is made ready. This petition is ordered accordingly.
