3. The petitioner charged for the offences under Sections 120 (b),167, 409,465,471,477(A) IPC and 13(2) r/w13(1)(c) and 13(1)(d) of preventing of anti-Corruption Act, 1988 in Crime No.1 of 2017 on the file of the respondent police.

4. Considering the reasons assigned for relaxation of condition and also the nature of charges pending against the petitioner, the condition already imposed on the petitioner is modified to the effect that the petitioner shall appear before the respondent
