Considering the reasons assigned for relaxation of condition and also the nature of charges pending against the petitioners, the condition already imposed on the petitioners is modified to the effect that the petitioners shall appear before the respondent Police once in a week i.e on every Monday at 10.30 am for a period



of four weeks and thereafter, as and when required for
interrogation on receipt of summons.
