Prayer in CRL MP(MD).5764/ 2017 in CRL OP(MD) No.3571 of 2017 :

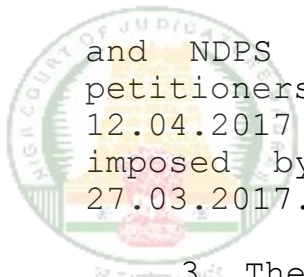
