Prayer in CRL MP(MD). 5834/ 2017 in Crl OP(MD)No.1529 of 2017:

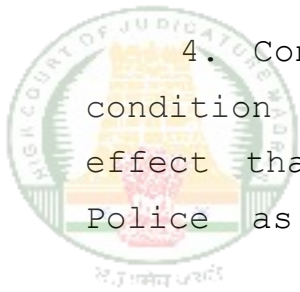
