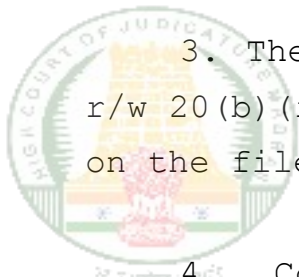

2.The learned Additional Public Prosecutor appearing for the respondent states that the petitioner is abiding the daily condition imposed by this Court regularly from 31.05.2017 onwards and the investigation is still pending.



3. The petitioner charged for the offences under Sections 8(c) r/w 20(b)(ii)(c), 29(1), 27A and 25 of NDPS Act in Crime No.84 of 2017 on the file of the respondent police.

4. Considering the reasons assigned for relaxation of condition, the condition already imposed on the petitioner is modified to the effect that the petitioner shall appear before the respondent Police, as and when required for interrogation on receipt of summons.
