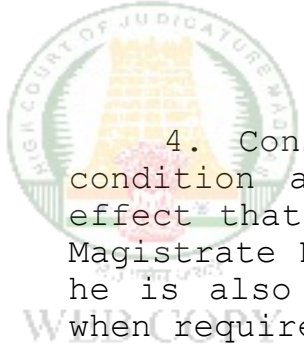

This petition is filed to modify the condition imposed by this Court in Crl.O.P(MD).No.8413 of 2017, dated 05.07.2017.

2.The learned counsel appearing for the petitioner states that the father of the deceased is an Auto Driver and he is having Auto stand nearby respondent Police Station and everyday when the petitioner appearing before the respondent Police for abiding the condition, the father of the deceased tried to create unwanted situation and threatened the petitioner herein.
