Advocate (Crl.Side) submitted that out of 36 witnesses cited in S.C.No.162 of 2009, 35 witnesses have been examined and the case is posted to 18.06.2017 for examination of the Investigating Officer.

Recording the same, this petition is closed with further direction to the learned District & Sessions Judge, Nagercoil, Kanyakumari District to dispose of S.C.No.162 of 2008 within four months from the date of receipt of a copy of this order. If the accused do not co-operate with the Court and abscond, a fresh FIR can be registered against them under Section 299-A IPC.
