He further submitted that the original documents are under the custody of DRT and hence, he seeks further 3 months time to complete the enquiry as per the direction given by this Court in Crl.O.P. (MD)No.5316 of 2017 on 27.04.2017.

3.Considering the facts and circumstances of the case and considering the reasons assigned in the affidavits filed in support of these petitions, 3 months time is granted to complete the investigation from the date on which the order copy is made ready. These petitions are ordered accordingly.
