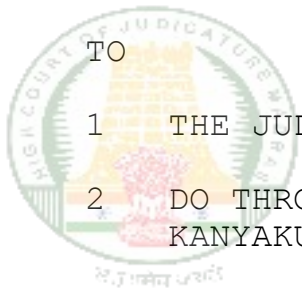
3. Considering the facts and circumstances of the case and considering the nature of charges, the earlier condition is relaxed. This petition is ordered accordingly.
