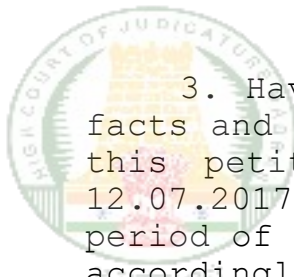
PRAYER IN CRL OP (MD) No.8778 of 2017:
