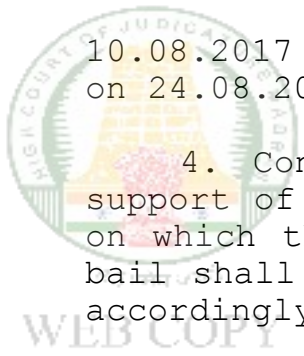

The petition is filed to extend the time to comply with the conditions imposed in the Criminal Original Petition.

2. This Court by order dated 03.08.2017 while granting anticipatory bail, directed the petitioners to appear before the concerned Court within a period of 15 days from the date on which the order copy is made ready, failing which, the petition for anticipatory bail stands dismissed.

10.08.2017 and the present petition for extension of time is filed on 24.08.2017. Hence, the petition is filed within time.
