3. On perusal of the records would show that this Court vide order dated 22.02.2017 has granted interim appeal bail and suspension of sentence to the petitioners till 22.03.2017.

4. The learned Government Advocate (Crl.Side) appearing for the respondent has no objection to suspend the sentence of imprisonment alone, till the disposal of the Appeal, since Appeal bail and suspension of sentence had already been granted by this Court.

5. Considering the above facts and circumstances of the case this Court is inclined to suspend the sentence of imprisonment alone, till the disposal of the Criminal Appeal.
