Prayer in CRL MP(MD). 8200/ 2017 :

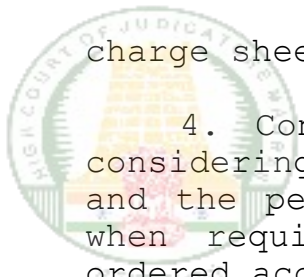
