The learned counsel for the petitioners and the learned Additional Public Prosecutor appearing for the respondent Police are present.

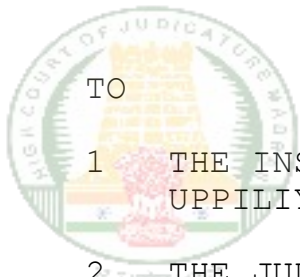
