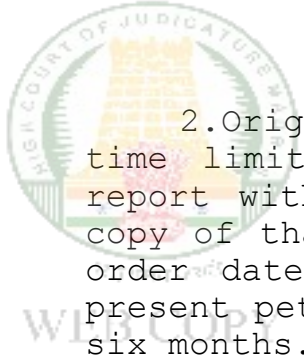

Criminal Original Petition is filed under Section 482 of Cr.P.C Praying this Hon'ble Court to withdraw the investigation pending in Cr. No.54 of 2014 on the file of the 4th respondent and enstruct the same to the CBCID or any other independent agency.

ORDER : This petition coming on for hearing upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of MR.K.ANBARASAN, Government Advocate (Crl.Side) appearing for the petitioners, the court made the following order :-
