2.This Court by order dated 16.08.2016 directing the petitioner to appear before the concerned Court within a period of 15 days from the date of receipt of a copy of the order. Since the petitioner failed to appear before the concerned Court, he preferred a petition for extension of time and this Court by order dated 26.09.2016 granted 2 weeks time. However, the petitioner failed to appear before the concerned Court again and filed the present petition for extension of further time after 3 months.

3.Considering the facts and circumstances of the case and also considering the reasons stated in the affidavit, this Court is inclined to grant 10 days time as last chance for complying with the



conditions on pay of Rs.1000/- to the Legal Services Authority, Dindigul from the date on which the order copy is made ready. Accordingly, this petition is ordered.
