Prayer in CRL MP(MD) . 7465/ 2017 :

Criminal Miscellaneous Petition filed under Section 439 (i)(b) of Criminal Procedure Code to modify one of the condition imposed by this Honourable Court in Crl.A.(MD)No.284 of 2017 vide order dated 31.07.2017 by directing the petitioner to report before any other police station or the Court concerned daily at 10.30 a.m. instead of reporting before the respondent police daily at 10.30 a.m.

Prayer in CRL A(MD) . 284/ 2017 :

Criminal Appeal filed Under Section 14 A(2) of SC and ST (POA) Amendment Act, 2015, to set aside the order Passed in Cr.M.P/No.1752/2017 dated 14.07.2017 on the file of the II Additional District and Sessions Judge cum PCR Court, Tiruenlveli and restore the appellant's complaint and enlarge the Petitioner on bail in connection with the case in Crime No.374 of 2017 pending investigation on the file of the respondent police herein.
