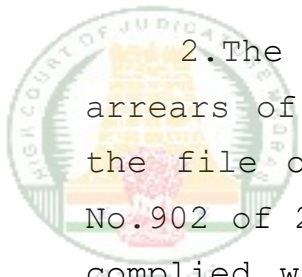

2.The respondent / petitioner was directed to deposit 50% of arrears of maintenance amount to the credit of M.C.No.8 of 2015 on the file of Family Court, Sivagangai as per order in Crl.M.P.(MD) No.902 of 2017, dated 09.02.2017 and the said condition was properly complied with. Hence, interim stay already granted by this Court was made absolute on 16.03.2017.

3.The learned counsel for the respondent / petitioner has no objection to withdraw the deposited amount by the petitioner / respondent.

4.Hence, the petitioner / respondent is permitted to withdraw the deposited amount on filing proper application before the Trial Court. Accordingly, this petition is allowed.
