3.The Learned Government Advocate (Crl. Side) appearing for the respondent Police submitted that the petitioner initially accepted the condition in order to get anticipatory bail before this Court. Accordingly, as per the request of the learned counsel for the petitioner, the said condition was imposed.

4.Considering the facts and circumstances of the case and also considering the learned Government Advocate (Crl.side) , I am not



inclined to modify the condition. Accordingly, this petition is dismissed.
