The learned counsel for the petitioner are present.

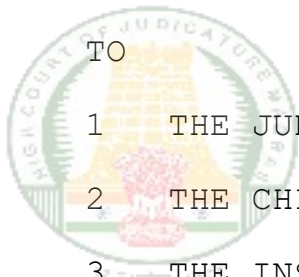
