2. Anticipatory bail was granted on 24.11.2016 directing the petitioners to appear before the concerned court within 15 days from the date of receipt of copy of this order.

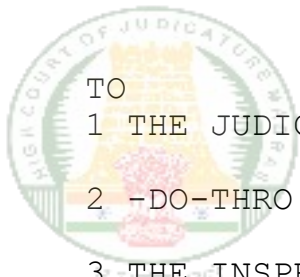
