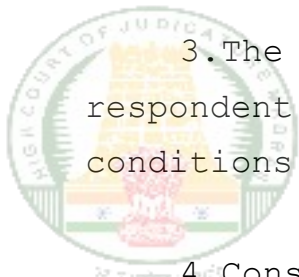

The petitioner filed this petition for modifying the condition imposed by this Court for the offences punishable under Sections 147, 148, 294(b), 302, 307 and 506(ii) of I.P.C., r/w. 120(b) of I.P.C., in Crime No.115 of 2017, while granting anticipatory bail.

3.The learned Government Advocate (Crl.side) appearing for the respondent Police submitted that the petitioner has not complied the conditions imposed by this Court and investigation is still pending.

4.Considering the Gravity of offence, facts and circumstances of the case and also considering the submission made by the learned Government Advocate (Crl. Side), I am not inclined to modify the condition imposed by this Court in Crl.O.P.(MD)No.11673 of 2017 dated 04.09.2017. Accordingly, this petition is dismissed.
