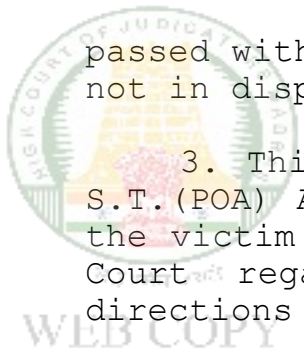

This Court is of the view that Section 15 A(5) of S.C. and S.T.(POA) Act, 2015, specifically, provides for Statutory Notice to the victim in all the cases whenever a petition is heard before any Court regarding grant of Bail, Anticipatory Bail and other directions in cases in relation to offences under Special Enactment.

4. Hence the petition to recall the order, dated 27.09.2017, in Crl.O.P.No.12914 of 2017 is allowed.

5. Post the matter for hearing both sides on 28.11.2017. In the meanwhile the petitioners shall not be harassed.
