PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

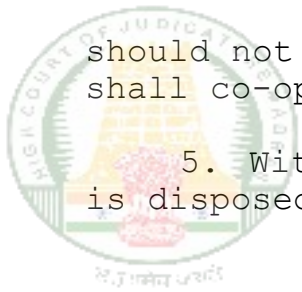
ORDER : The Court Made the following order :-

The petitioners, who is arrayed as accused, apprehend arrest at the hands of the respondent police for the offences under Sections 294(b), 506(ii) of IPC in Crime No. not known of 2017 seek anticipatory bail

2. The learned counsel appearing for the petitioners states that the petitioners are being harassed under the guise of enquiry.

3. The learned Additional Public Prosecutor appearing for the respondent, on instructions, would submit that petition enquiry is pending in C.S.R.No.439 of 2017 dated 12.08.2017 on the file of the respondent Police and the alleged threat or harassment by the respondent Police is not true.

should not harass the petitioners during enquiry and the petitioners shall co-operate with the enquiry.
