3.The learned counsel for the petitioners submitted that the respondent Police is harassing the petitioner under the guise of enquiry. The learned counsel for the intervenor is also present.

4.Considering the facts and circumstances of the case and also considering the submission made by the learned Additional Public Prosecutor the respondent Police is directed to register an FIR if any prima facie made out or close the enquiry in accordance with law as expeditiously as possible and the respondent Police should not



harass the petitioner during enquiry and both parties shall cooperate with the enquiry.

5. With the above observations, this Criminal Original petition is disposed of and the intervening petition is closed.
