PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who is arrayed as accused apprehends arrest at the hands of the respondent police for the offences under Sections 406, 506(ii) of IPC in Crime No. not known of 2017 seeks anticipatory bail.

2.The learned counsel appearing for the petitioner states that the petitioner is being harassed under the guise of enquiry.

3.The learned Additional Public Prosecutor appearing for the respondent would submit on instructions that the enquiry is pending in CSR.No.369 of 2017 dated 04.09.2017 on the file of the respondent Police and the alleged threat or harassment by the respondent Police is not true.

4.Considering the facts and circumstances of the case, the respondent Police is directed to register the FIR if any prima facie case made out and close the enquiry as expeditiously as possible and the respondent Police should not harass the petitioner under the guise of enquiry. Further the petitioner is directed to co-operate



with the respondent Police for investigation.

5. With the above observations, the Criminal Original Petition is disposed of.
