Durai Pandian, learned Additional Public Prosecutor appearing for the respondents 1 and 2 on instructions submitted <https://hcmcs.ecourts.gov.in/hcmcs/> complaint was received from the respondents 3 and 4, since the dispute is purely civil in nature, after enquiry the complaint was closed on 05.09.2017. He further submitted that



there is no question of harassment and no further enquiry is contemplated.

4. Recording the said statement made by the learned Additional Public Prosecutor, the Criminal Original Petition is closed.
