This Criminal Original Petition has been filed to quash C.C.No.15 of 2013, pending on the file of the learned Judicial Magistrate No.II, Karur District.

2.Though the learned counsel for the petitioner raised several grounds for quashing the case in C.C.No.15 of 2013, on the file of the learned Judicial Magistrate No.II, Karur, he submitted that it would suffice, if a direction is issued to the trial Court to complete the trial within a time limit that may be stipulated by this Court and also to permit the petitioner to raise all the grounds raised in this petition before the trial Court.



3.I have heard the learned counsel on either side and the learned Government Advocate (Criminal side) appearing for the first respondent has also conceded the request of the learned counsel for the petitioner.
