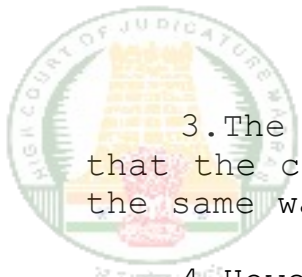

This Criminal Original petition has been filed seeking a direction to the first and second respondents to give police protection to the petitioner for doing agricultural operations in the land bearing Survey Nos.239/1 & 239/2 to an extent of 2 acre and 75 cents situated at Kalamman Kovil Street, Kamarajapuram, Theni District based on petitioner's representation dated 19.07.2017.

2. Heard the learned counsel appearing for the petitioner and the learned counsel for Government Advocate(Criminal side) appearing for the respondents 1 and 2.



3.The learned Government Advocate (Criminal side) would submit that the complaint of the petitioner has already been enquired and the same was closed.

4.However, according the petitioner, her previous complaint dated 19.07.2017 has not been considered.
