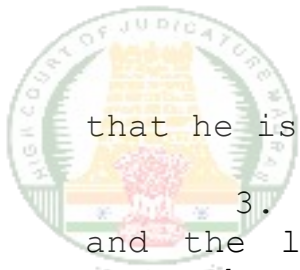

This petition is filed for issuing a direction to the 2nd respondent to give Police Protection for the life and limb of the petitioner and his family members on the basis of the petitioner's representation dated 09.08.2017.

2. In the representation of the petitioner the petitioner states that he is the owner of the property measuring an extent of 28.5 Ares in S.No.423 / 2B situated at Kavalakurichi Village, Alangulam Taluk, Thirunelveli District and that when the petitioner entered into his above said property, it is stated by the petitioner that he was prevented by few individuals claiming certain rights over the properties. The claim of the petitioner



that he is the owner of the property.
