2. Heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for respondents 1 to 3.

3. The petitioner himself admitted that he borrowed a sum of Rs.40,000/- from one Arumugam as loan on 11.07.2017. He further admitted that the said Arumugam was found missing from 31.08.2017.

4. It appears that the petitioner has used the ATM card of the



said Arumugam, after the complaint was registered about the missing of the said Arumugam and that he had taken some money using the ATM card. After the said Arumugam was found missing, the petitioner is a suspect. It was only in connection with the complaint, the petitioner was called for an enquiry.
