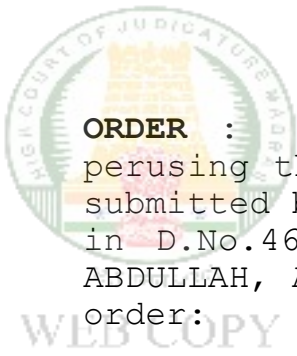

Prayer in CRL OP(MD) . 15002/ 2017 :

ORDER : This petition coming on for hearing on this day, upon perusing the earlier order of this court and the requisition letter submitted by the Judicial Magistrate no.II, Dindigul vide the letter in D.No.465/2018 dated 14.03.2018 and in the presence of M.SHEIK ABDULLAH, Advocate for the petitioner, this court made the following order:

This Court, by an order dated 07.11.2017 in CrI.O.P.(MD) No.15002 of 2017, directed the learned Judicial Magistrate No.II, Dindigul to dispose of the case in C.C.No.488 of 2016, within a period of three months from the date of receipt of that order.

2.Now, the learned Judicial Magistrate No.II, Dindigul by letter dated 14.03.2018 seeks further three months time to dispose of the case in C.C.No.488 of 2016.
