petitioners are directed to surrender before the trial Court within a period of two weeks from the date of receipt of a copy of this order and on such surrender, the learned Special Judge for SC/ST (Prevention of Atrocities) Act / Principal District & Sessions Judge (PCR Unit), Srivilliputhur at Virudhunagar District, is directed to consider the bail petition filed by the petitioners in connection with Crime No.242 of 2017, on merits and in accordance with law, after issuing notice to the victims under Section 15 (A) of the SC/ST Act.

2. With the above direction, this Criminal Original Petition is disposed of.
