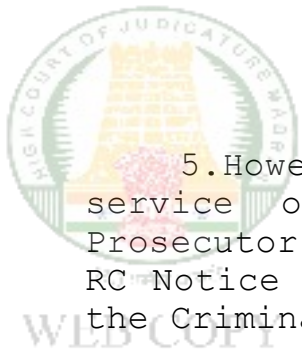
O R D E R

The Criminal Original Petition is filed for a direction to the respondents to conduct the investigation and to file the final report in Crime No.84 of 2016, on the file of the second respondent police before the concerned Court within the stipulated time frame as fixed by this Court.

2.Heard Mr.B.Jameel Arasu, learned Counsel appearing for the petitioner and Mr.K.S.Durai Pandian, learned Additional Public Prosecutor, who takes notice for the respondents.

3.The petitioner is the de-facto complainant in Crime No.84 of 2016. The petitioner gave a complaint before the second respondent and the same was registered in Crime No.84 of 2016, for the offences punishable under Sections 147, 420 and 506(i) IPC. It is further stated that after the registration of the case, there was no further investigation and a direction from this Court to the respondents to file a final report will be in the interest of justice.
