has been settled before the Mediation and Conciliation Centre. A
report was also received from the Mediation and Conciliation Centre
stating that the mediation has succeeded in this case. It is
admitted that both are living together and (*)**'the revision
petitioner is entitled to withdraw the amount of Rs.38,500/- (Rupees
Thirty Eight Thousand and Five Hundred) deposited by him, before the
District Munsif cum Judicial Magistrate Court at peraiyur'.**

parties, this Criminal Revision Case is closed. The Mediation Report



as well as Mediation Agreement shall form part of this order.
Consequently, connected M.P.(MD) No.1 of 2014 is also closed.
