Therefore, the petitioner is directed to surrender before the trial Court within a period of two weeks from the date of receipt of a copy of this order and on such surrender, I Additional District Judge cum PCR Court, Madurai is directed to consider the bail petition filed by the petitioner in connection with Crime No.597 of 2017, on merits and in accordance with law, after issuing notice to the victims under Section 15 (A) of the SC/ST Act.
