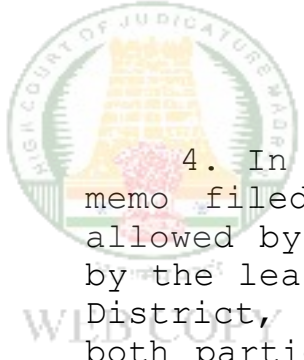

The matter was referred to Mediation Centre on 11.11.2016 and the case was settled before the Mediation Centre by way of Mediation Agreement Report, dated 27.02.2017, which is also received by this court.

3. Both parties today jointly filed a compromise memo signed by the parties and their respective counsels stating that the dispute between the parties are settled. The revision petitioner has appeared and produced his Aadhar Card bearing No.975448538046 and the first respondent along with her minor child appeared before this Court and also produced her Aadhar Card bearing No.723506137646 for identification before this Court.
