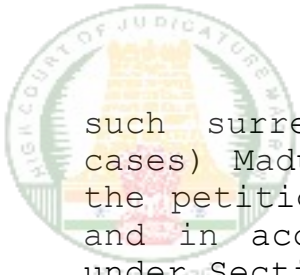

In view of the amendments made in the Scheduled Castes and the Scheduled Tribes(Prevention of Atrocities) Act, 1989, this Court is of the view that the usual directions that were issued by this Court cannot be issued routinely in all cases. such surrender, the learned Additional District Judge-III (PCR cases) Madurai, is directed to consider the bail petition filed by the petitioners in connection with Crime No.820 of 2017, on merits and in accordance with law, after issuing notice to the victims under Section 15 (A) of the SC/ST Act.
